What data do we collect?

When you register to sail on Sailonline you choose a Username to be your boat name and set a password which is encrypted in our server. To complete registration you need to supply a valid email address.

How do we collect your data?

You directly provide Sailonline with most of the data we collect. We collect data and process data when you:

- Register a Username
- Contact us by email.
- Register to sail in a race
- Join the Sailonline Yacht Club

How will we use your data?

Sailonline collects your data so that we can:

- Ensure you have access to racing
- Email you, if you are an SYC member, with a reminder to renew your membership
- Email you if you forget your password and request an automated password reset
- Email you if someone asks us to share their email address with you and we are seeking your permission to share it

How do we store your data?

Sailonline securely stores your data at:

Your e-mail address can only be accessed by you and Sailonline volunteers, who have all signed Sailonline's NDA, via password protected accounts. IP addresses can only be accessed by those Sailonline volunteers who signed the NDA using a personal public/private key pair for authentication and encryption.

At all times the data you have provided to Sailonline remains under your control – if you choose, you may remove the first and family names supplied when creating your account. Should you decide to stop racing with us and send us a request to deactivate your account, the first name, family name and email address fields in our database will be deleted and your Username set to inactive.

Marketing

Sailonline may choose to send you information about special races or events that we think you might like – please note this is not something currently undertaken.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Sailonline from contacting you for marketing purposes.

What are your data protection rights?

Sailonline would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Sailonline for a copy of your personal data.

The right to rectification – Although you have complete control over your information, you have the right to request that Sailonline corrects any information you believe is inaccurate. You also have the right to request Sailonline to complete information you believe is incomplete.

The right to erasure — You have the right to request that Sailonline erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Sailonline restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Sailonline’s processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Sailonline transfer the data that we have collected to another organization, or directly to you, under certain conditions.

What are cookies?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our website, we may collect information from you automatically through cookies or similar technology.

How do we use cookies?

Sailonline uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functional - Sailonline uses these cookies for persistent login, so that you are recognised on our website and your previously selected preferences remembered. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies is used.
- Analytical - these are used for Google analytics. Sites we link to of sailing and other organisations associated with our racing may themselves contain cookies.
